FEES: \$8.00 first entry in conformation; \$4.00 each additional entry of same dog in conformation or obedience.
\$6.00 for Sweeps entry - Dog must be entered in a regular class.
\$8.00 first entry in obedience; \$4.00 each additional entry of same dog.

CLASSES:

BREED (Golden Retrievers only): Puppy 3-6, 6-9, 9-12, Adult 12-18, Bred by Exhibitor, American Bred, Novice, Open, Veterans, Field Trial/Hunt, Stud Dog, Brood Bitch, Brace

Sexes divided. Professional Handlers may show only their own dogs. No dogs with a major, except in Veterans. All dogs must be 3 months of age or older for conformation classes. Winners of non-regular classes are not eligible for Best Adult in Match or Best Opposite Sex in Match.

SWEEPS (Golden Retrievers only): Puppy 3-6, 6-9, and 9-12 Puppy, and Veterans

JR. SHOW: Juniors (8-13 yrs) and Seniors (14-17 yrs): Novice and Open

OBEDIENCE (All Breeds): Regular: Novice A & B, Open A & B, Utility;

Non-Regular: Pre-Novice, Graduate Novice, and Veterans.

All dogs must be 6 months of age or older for Obedience classes. Winners of Non-Regular classes are not eligible for Highest Scoring Dog or Puppy.
